Induction into the Hall of Fame is intended to be a special honor to living persons rather than a memorial to those who have passed away. It represents the highest honor that KAPT can bestow upon an individual in school transportation. Nominees should be exemplary leaders in school bus safety.

Selections will be based upon significant contribution to school bus safety issues and KAPT, including but not limited to:

maintaining awareness of and/or participating in significant national and state studies or pilot programs related to school transportation safety;

keeping district staff apprised of current school bus safety issues;

promoting improved public relations on behalf of school transportation safety;

diligently serving the cause of pupil transportation and the Kentucky Association for Pupil Transportation through service and contributions.

Current local transportation personnel, state transportation personnel and transportation industry personnel are NOT eligible to receive this award.

Current local transportation personnel, state transportation personnel and transportation industry personnel who are no longer on an active status but whose major contributions were made while the individual was an active member in local transportation operation, state transportation operation or industry operation and was a member of KAPT while employed and whose major contributions and/or in-kind-service to KAPT were for school transportation safety on a national, state and/or industry level ARE eligible for this award.

Any local, state or industry personnel whose major contributions and/or in-kind-services to school bus safety were made during the individual's "post active" years MAY be eligible for this award.

The selection committee will have the option to posthumously award an individual deemed worthy of this honor.
